

**ASSEMBLY AMENDMENT 34,  
TO 2003 SENATE BILL 44**

June 19, 2003 – Offered by Representative SCHOOFF.

1           At the locations indicated, amend the bill, as shown by senate substitute  
2 amendment 1, as follows:

3           **1.** Page 98, line 3: decrease the dollar amount for fiscal year 2003–04 by  
4 \$232,000 and decrease the dollar amount for fiscal year 2004–05 by \$232,200 to  
5 decrease funding for the purpose for which the appropriation is made.

6           **2.** Page 106, line 7: decrease the dollar amount for fiscal year 2003–04 by  
7 \$7,520 and decrease the dollar amount for fiscal year 2004–05 by \$7,520 to decrease  
8 funding for the purpose for which the appropriation is made.

9           **3.** Page 106, line 10: decrease the dollar amount for fiscal year 2003–04 by  
10 \$10,600 and decrease the dollar amount for fiscal year 2004–05 by \$10,600 to  
11 decrease funding for the purposes for which the appropriation is made.

12           **4.** Page 106, line 10: after that line insert:

1       “(kh) American Indian economic devel-  
 2               opment; liaison — grants               PR-S    A           23,000       23,000”.

3               **5.** Page 106, line 12: decrease the dollar amount for fiscal year 2003–04 by  
 4       \$227,100 and decrease the dollar amount for fiscal year 2004–05 by \$227,100 to  
 5       decrease funding for the purposes for which the appropriation is made.

6               **6.** Page 106, line 14: decrease the dollar amount for fiscal year 2003–04 by  
 7       \$39,100 and decrease the dollar amount for fiscal year 2004–05 by \$39,100 to  
 8       decrease funding for the purposes for which the appropriation is made.

9               **7.** Page 120, line 5: decrease the dollar amount for fiscal year 2003–04 by  
 10       \$63,000 and decrease the dollar amount for fiscal year 2004–05 by \$63,000 to  
 11       decrease funding for the purpose for which the appropriation is made.

12              **8.** Page 120, line 10: decrease the dollar amount for fiscal year 2003–04 by  
 13       \$32,300 and decrease the dollar amount for fiscal year 2004–05 by \$32,300 to  
 14       decrease funding for the purpose for which the appropriation is made.

15              **9.** Page 122, line 8: decrease the dollar amount for fiscal year 2003–04 by  
 16       \$15,200 and decrease the dollar amount for fiscal year 2004–05 by \$15,200 to  
 17       decrease funding for the purpose for which the appropriation is made.

18              **10.** Page 127, line 13: after that line insert:  
 19       “(kj) Grant to Beloit College               PR     A           46,000       46,000  
 20       (km) Alternative school American  
 21               Indian language and culture  
 22               education aid                               PR-S    A           239,200       239,200”.

1           **11.** Page 132, line 6: increase the dollar amount for fiscal year 2003–04 by  
2           \$130,000 and increase the dollar amount for fiscal year 2004–05 by \$130,000 to  
3           increase funding for the purpose for which the appropriation is made.

4           **12.** Page 137, line 9: increase the dollar amount for fiscal year 2003–04 by  
5           \$252,000 and increase the dollar amount for fiscal year 2004–05 by \$252,000 to  
6           increase funding for the purpose for which the appropriation is made.

7           **13.** Page 141, line 19: decrease the dollar amount for fiscal year 2003–04 by  
8           \$8,000 and decrease the dollar amount for fiscal year 2004–05 by \$8,000 to decrease  
9           funding for the purposes for which the appropriation is made.

10          **14.** Page 142, line 8: decrease the dollar amount for fiscal year 2003–04 by  
11          \$3,600 and decrease the dollar amount for fiscal year 2004–05 by \$3,600 to decrease  
12          funding for the purpose for which the appropriation is made.

13          **15.** Page 147, line 18: decrease the dollar amount for fiscal year 2003–04 by  
14          \$82,100 and decrease the dollar amount for fiscal year 2004–05 by \$82,100 to  
15          decrease funding for the purposes for which the appropriation is made.

16          **16.** Page 151, line 11: decrease the dollar amount for fiscal year 2003–04 by  
17          \$10,300 and decrease the dollar amount for fiscal year 2004–05 by \$10,300 to  
18          decrease funding for the purposes for which the appropriation is made.

19          **17.** Page 155, line 10: decrease the dollar amount for fiscal year 2003–04 by  
20          \$40,000 and decrease the dollar amount for fiscal year 2004–05 by \$40,000 to  
21          decrease funding for the purposes for which the appropriation is made.

1           **18.** Page 158, line 2: increase the dollar amount for fiscal year 2003–04 by  
2           \$210,000 and increase the dollar amount for fiscal year 2004–05 by \$210,000 to  
3           increase funding for the purpose for which the appropriation is made.

4           **19.** Page 164, line 6: decrease the dollar amount for fiscal year 2003–04 by  
5           \$8,000 and decrease the dollar amount for fiscal year 2004–05 by \$8,000 to decrease  
6           funding for the purpose for which the appropriation is made.

7           **20.** Page 167, line 19: decrease the dollar amount for fiscal year 2003–04 by  
8           \$317,600 and decrease the dollar amount for fiscal year 2004–05 by \$317,600 to  
9           decrease funding for the purposes for which the appropriation is made.

10          **21.** Page 167, line 20: decrease the dollar amount for fiscal year 2003–04 by  
11          \$10,400 and decrease the dollar amount for fiscal year 2004–05 by \$10,400 to  
12          decrease funding for the purpose for which the appropriation is made.

13          **22.** Page 168, line 11: decrease the dollar amount for fiscal year 2003–04 by  
14          \$2,500 and decrease the dollar amount for fiscal year 2004–05 by \$2,500 to decrease  
15          funding for the purpose for which the appropriation is made.

16          **23.** Page 197, line 12: decrease the dollar amount for fiscal year 2003–04 by  
17          \$64,000 and decrease the dollar amount for fiscal year 2004–05 by \$64,000 to  
18          decrease funding for the purpose for which the appropriation is made.

19          **24.** Page 197, line 14: decrease the dollar amount for fiscal year 2003–04 by  
20          \$85,600 and decrease the dollar amount for fiscal year 2004–05 by \$85,600 to  
21          decrease funding for the purposes for which the appropriation is made.

1           **25.** Page 200, line 15: decrease the dollar amount for fiscal year 2003–04 by  
2           \$9,600 and decrease the dollar amount for fiscal year 2004–05 by \$9,600 to decrease  
3           funding for the purpose for which the appropriation is made.

4           **26.** Page 204, line 12: decrease the dollar amount for fiscal year 2003–04 by  
5           \$21,800 and decrease the dollar amount for fiscal year 2004–05 by \$21,800 to  
6           decrease funding for the purpose for which the appropriation is made.

7           **27.** Page 204, line 14: decrease the dollar amount for fiscal year 2003–04 by  
8           \$40,000 and decrease the dollar amount for fiscal year 2004–05 by \$40,000 to  
9           decrease funding for the purpose for which the appropriation is made.

10          **28.** Page 204, line 16: decrease the dollar amount for fiscal year 2003–04 by  
11          \$40,000 and decrease the dollar amount for fiscal year 2004–05 by \$40,000 to  
12          decrease funding for the purpose for which the appropriation is made.

13          **29.** Page 213, line 2: decrease the dollar amount for fiscal year 2003–04 by

19          **31.** Page 216, line 13: decrease the dollar amount for fiscal year 2003–04 by  
20          \$5,600 and decrease the dollar amount for fiscal year 2004–05 by \$5,600 to decrease  
21          funding for the purpose for which the appropriation is made.

1           **32.** Page 233, line 13: decrease the dollar amount for fiscal year 2003–04 by  
2           \$20,000 and decrease the dollar amount for fiscal year 2004–05 by \$20,000 to  
3           decrease funding for the purpose for which the appropriation is made.

4           **33.** Page 234, line 2: decrease the dollar amount for fiscal year 2003–04 by  
5           \$40,000 and decrease the dollar amount for fiscal year 2004–05 by \$40,000 to  
6           decrease funding for the purpose for which the appropriation is made.

7           **34.** Page 239, line 17: decrease the dollar amount for fiscal year 2003–04 by  
8           \$20,000 and decrease the dollar amount for fiscal year 2004–05 by \$20,000 to  
9           decrease funding for the purpose for which the appropriation is made.

10          **35.** Page 239, line 18: increase the dollar amount for fiscal year 2003–04 by  
11          \$266,000 and increase the dollar amount for fiscal year 2004–05 by \$266,000 to  
12          increase funding for the purpose for which the appropriation is made.

13          **36.** Page 280, line 17: delete the material beginning with that line and ending  
14          with page 281, line 5.

15          **37.** Page 286, line 1: delete that line.

16          **38.** Page 286, line 3: delete that line.

17          **39.** Page 352, line 2: delete “\$3,000,000” and substitute “\$2,760,000”.

18          **40.** Page 352, line 4: delete that line.

19          **41.** Page 352, line 9: delete lines 9 and 10.

20          **42.** Page 782, line 17: delete that line.

21          **43.** Page 783, line 22: delete that line.

22          **44.** Page 979, line 25: delete that line.
