

2 1. Page 1011, line 19: after that line insert:

3 "SECTION 2805m. 980.08 (7) of the statutes is created to read:

4 980.08 (7) The department shall not renew any agreement or contract related
5 to the location or provision of housing to persons eligible for supervised release under
6 this section with Attic Correctional Services when that agreement or contract
7 expires and shall not enter into aⁿ agreement or contract related to the location or
8 provision of housing to persons eligible for supervised release under this section with
9 that corporation after the effective date of this subsection...[reviser inserts date]."
