out Mental Health Medication Review Committee. Require the DHFS Secretary to exercise his or her authority to create a Mental Health Medication Review Committee to advise DHFS on implementation of prior authorization requirements for selective serotonin reuptake inhibitors, a type of antidepressant medication, and on implementation of a process for reviewing utilization of drugs to treat mental illness under MA. Require the Secretary to appoint at least one advocate for people with mental illness and at least one consumer of a drug used to treat a mental illness as members of the Committee and specify that advocates and consumers must constitute a majority of the Committee. This provision would be effective on the bill's general effective date.

out Supplemental MA Payments to Kilbourn Care Center. Require DHFS to allocate \$405,100 GPR in 2003-04 and \$405,500 GPR in 2004-05 from funding budgeted in the MA benefits appropriation as a payment to Milwaukee County to support a two-year demonstration project that involves a nursing facility that: (a) has between 80 and 90 licensed beds; (b) has at least 90% of its residents supported by MA; and (c) is located in the City of Milwaukee. Kilbourn Care Center would likely meet all of these criteria.

out Minority Business Certification Program. Require statewide uniform certification of minority businesses through the Department of Commerce. Commerce would be required to prescribe a uniform application process by rule, but could not require applicants to file a copy of their tax return, or federal certification application, as a condition for qualification for certification. However, Commerce may require a signed affidavit stating all information that is submitted is true and correct. All school board, local governmental, and county ordinances regarding minority business certification would be required to conform to state certification rules and laws.
