At the locations indicated, amend the this as follows:

1. Page 2, line 2: after "balance;" insert "earmarking moneys in the Wisconsin

development fund for specified purposes;".

2. Page 7, line 1: after that line insert:

"Section 9109. Nonstatutory provisions; commerce.

(1m) Earmarked Wisconsin development fund moneys. During the period beginning on the effective date of this subsection and ending on June 30, 2003, the department of commerce shall take actions to ensure that \$1,500,000 from the appropriation under section 20.143 (1) (ie) of the statutes is available for grants and loans under subchapter V of chapter 560 of the statutes, except section 560.65 of the statutes and for loans under section 560.147 of the statutes, for grants under sections 560.16, 560.175, and 560.25 of the statutes, for assistance under section 560.06 (2) of the statutes, and for reimbursements under section 560.167 of the statutes, all for

the purpose of job creation and job retention in the cities of Cumberland, Manitowoc, and Chippewa Falls. This subsection does not require the department of commerce to disburse moneys to any person who fails to satisfy all applicable requirements for the receipt of moneys under the programs described in this subsection.".

3. Page 6, line 16: delete \$7,000,000" and substitute "\$5,500,000".

**4.** Page **6**, line 1**6**: after that line insert:

"(1m) Additional Wisconsin development fund appropriation lapse. On June 30, 2003, the amount determined under this subsection is lapsed from the appropriation under section 20.143 (1) (ie) of the statutes. The amount of the lapse required under this subsection is the amount by which disbursements from and obligations of moneys earmarked under Section 9109 (1m) of this act is less than \$1,500,000.".
