

PS I have forwarded this amendment drafting request to Steve Miller in case Joe Kreye is not in on Monday (at all or on a timely basis) so that the amendment drafting can be reassigned.

Amend AB 378 as follows:

On Page 13, delete the material beginning at line 14 and ending on page 14, line 6.

Insert the following language in place of the deleted material:

The commission may not permit a utility as defined in s. 196.374(1)(c) to recover in rates payments to compensate local units of government for the impacts of a generating facility on that local unit of government, unless the utility demonstrates that such payments are reasonable and appropriate under the particular circumstances, taking account of the utility aid payments set forth in s. 79.04. ←

Intent: the phrase "impacts . . . on that local unit of government" is intended to include health, safety and environmental impacts on the citizens living within the boundaries of the local unit of government's jurisdiction.

The provision is intended to only cover Class A electric utilities as defined by the PSC. Those are: Consolidated Water Power Company, Madison Gas and Electric Company, Northern States Power-Wisconsin, Superior Water Light and Power Company, WEPCO, WP&L and WPS.

2 1. Page 13, line 14: delete the material beginning with that line and ending
3 on page 14, line 6, and substitute:
