- ↓ **2.** Page <sup>7</sup>6, line <sup>15</sup>10: after "revenue" insert ", except as provided under sub. (2m),".
- 3.** Page <sup>8</sup>7, line <sup>10</sup>24: after that line insert:  
 "SECTION 14m. 79.04 (2m) of the statutes is created to read:  
 79.04 (2m) Beginning with the distribution in 2005, the calculation of payments to municipalities under sub. (1) and to counties under sub. (2) shall not include depreciation."
