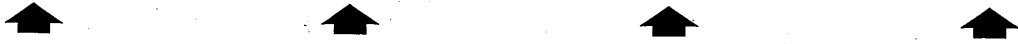

7 **3.** Page 13, line 10: delete "dealer, pawnbroker" and substitute "mortgage
8 banker, mortgage broker, pawnbroker".

9 **4.** Page 13, line 19: after "bearer form" insert ", book entry,".

10 **5.** Page 13, line 20: after "delivery" insert "or transfer".
