2 1. Page 16, line 9: after that line insert:

3 **"SECTION 33m. Appropriation changes.**

4 (1) PRIVATE EMPLOYER HEALTH CARE COVERAGE PROGRAM. In the schedule under
5 section 20.005 (3) of the statutes for the appropriation to the department of employee
6 trust funds under section 20.515 (2) (a) of the statutes, as affected by the acts of 2003,
7 the dollar amount is increased by \$210,900 for fiscal year 2003-04 and the dollar
8 amount is increased by \$210,900 for fiscal year 2004-05 to increase funding for the
9 purpose for which the appropriation is made.

1 (2) GENERAL PROGRAM SUPPLEMENTATION. In the schedule under section 20.005
 2 (3) of the statutes for the appropriation to the joint committee on finance under
 3 section 20.865 (4) (a) of the statutes, as affected by the acts of 2003, the dollar amount
 4 is decreased by \$210,900 for fiscal year 2003-04 and the dollar amount is decreased
 5 by \$210,900 for fiscal year 2004-05 to decrease funding allocated for operating costs
 6 related to the private employer health care coverage program." ✓
