1 At the locations indicated, amend the bill as follows:

2 1. Page ¹⁶17, line ¹³8: after "2005" insert ", if the apportionment formulas under
3 section 71.45 (3) (intro.), (a), and (b) and (3m) of the statutes are approved by the joint
4 committee on finance and by the governor, as provided under section 13.10 of the
5 statutes, after July 1, 2005".

6 2. Page ¹⁶17, line ¹³8: after that line insert:

7 "SECTION 34m. Effective date.

8 (1) SINGLE SALES FACTOR APPORTIONMENT. This act takes effect on January 1,
9 2006, if the apportionment formulas as provided under the act are approved by the
10 joint committee on finance and by the governor, as provided under section 13.10 of
11 the statutes, after July 1, 2005."
