11           apportionment provisions under sections 71.04, 71.25, and 71.45 of the statutes. The  
12           audit shall examine the impact of single sales factor apportionment on the state’s  
13           economy, especially as it relates to creating jobs in this state. The audit shall  
14           examine single sales factor apportionment as it relates to taxable years beginning  
15           after December 31, 2007, and ending before January 1, 2012. If the legislative audit  
16           bureau performs the audit, it shall file its report as described under section 13.94 (1)  
17           (b) by December 31, 2012.”.
