**SENATE AMENDMENT ,
TO 2003 ASSEMBLY BILL 1**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 15: delete “, (4g) and (4r)”.

3 **2.** Page 3, line 16: delete “are” and substitute “is”.

4 **3.** Page 3, line 18: after that line insert:

5 **“SECTION 2e.** 19.42 (3s) of the statutes is created to read:

6 19.42 (3s) “Candidate for local public office” means any individual who files
7 nomination papers and a declaration of candidacy under s. 8.21 or who is nominated
8 at a caucus under s. 8.05 (1) for the purpose of appearing on the ballot for election
9 as a local public official or any individual who is nominated for the purpose of
10 appearing on the ballot for election as a local public official through the write-in
11 process or by appointment to fill a vacancy in nomination and who files a declaration
12 of candidacy under s. 8.21.
