1. Page 4, line 15: after that line insert:

^{3m} "SECTION 19.35 (1) (i) of the statutes is amended to read: ^{plain space}

19.35 (1) (i) Except as authorized under this paragraph and except as provided in s. 19.36 (13), no request under pars. (a) and (b) to (f) may be refused because the person making the request is unwilling to be identified or to state the purpose of the request. Except as authorized under this paragraph, no request under pars. (a) to (f) may be refused because the request is received by mail, unless prepayment of a fee is required under sub. (3) (f). A requester may be required to show acceptable identification whenever the requested record is kept at a private residence or whenever security reasons or federal law or regulations so require."

3. Page 5, line 11: after "shall" insert "contain the name and address of the requester and shall".

4. Page 9, line 19: delete "(12)" and substitute "(13)".

5. Page 11, line 18: after that line insert:

"(13) ACCESS TO CERTAIN PERSONNEL RECORDS. If an authority receives a request to inspect or copy a record for which notice to the record subject is required under s. 19.356 (2) (a), the authority shall not provide access to the record unless the

requester provides the requester's name and address and the

requester demonstrates that the public interest in providing access to that record outweighs the public interest in withholding access to that record.”
