Besides the unnecessary level of detail (for a statute) and wordy drafting style that doesn't conform to Wisconsin practices, I see some other problems with the attached proposal. Foremost, it results in a prepaid subscriber paying sales tax on the surcharge whereas "regular" subscribers do not. (I'd expect that the amount of the sales tax for any one prepaid subscriber would be small, e.g., 5.5% of, say, 2 months of surcharges or 5.5% of about \$1.) Second, the proposal requires the state to conform its billing and "remitting" requirements to the "wireless provider's existing operating or technological abilities." With at least 11 providers in the state, it could be difficult for the state's program and requirements to conform to all of these existing "abilities."

Let me know if you'd like some options on dealing with this issue.

PREPAID WIRELESS LANGUAGE¹

"Active prepaid wireless telephone" means a prepaid wireless telephone that has been used by the customer during the month to complete a telephone call for which the customer's card or account was decremented.

"Mobile telephone number" or "MTN" shall mean the telephone number assigned to a wireless telephone at the time of initial activation.

"Prepaid wireless telephone service" means wireless telephone service which is activated in advance by payment for a finite dollar amount of service or for a finite set of minutes which terminate either upon use by a customer and delivery by the wireless provider of an agreed-upon amount of service corresponding to the total dollar amount paid in advance or within a certain period of time following the initial purchase or activation, unless additional payments are made.

"Sufficient positive balance" means a dollar amount greater than or equal to the monthly wireless surcharge amount.

In the case of prepaid wireless telephone service, the monthly wireless 911 surcharge imposed by [cite to appropriate section(s)] shall be remitted based upon each prepaid wireless telephone associated with this State, for each wireless service customer that has a sufficient positive balance as of the last day of each month. surcharge shall be remitted in any manner consistent with the wireless provider's existing operating or technological abilities, such as customer address, location associated with the MTN, or reasonable allocation method based upon other comparable relevant data. The surcharge amount or an equivalent number of minutes may be reduced from the prepaid subscriber's account since a direct billing may not be possible. However, collection of the wireless 911 surcharge in the manner of a reduction of value or minutes from the prepaid subscriber's account shall not reduce the sales price for purposes of taxes which are collected at the point of sale.

¹ This language is NOT an endorsement of the imposition of E911 fees on prepaid accounts. It is intended to be used only in situations where the imposition of such fees to prepaid accounts is inevitable. These provisions are intended to minimize as much as possible the administrative burden and costs associated with complying with such a policy.

Here's a sentence that Mark can work with for fees for prepaid customers:

Page 8, insert after line 22:

1m. The commissions shall, by rule, establish a surcharge in lieu of the fee under subd. 1. that applies to customers who buy wireless telephone service on a pre-paid basis.

Comments:

1. You may want to require that the surcharge for prepaid service be "equitable" relative to the standard surcharge.

2. You will want the other aspects of subd. 1. (i.e., when the surcharge applies), and the rest of par. (f) to apply to the prepaid surcharge, too.
