Hi Mark:

We have another drafting request.

We would like a substitute amendment to AB 61, or an amendment to ASA2 to AB 61 to say something to this effect: In relation to the grant awarded to the wireless providers, the PSC must promulgate rules that recommend a portion of that grant be used (in a good faith effort) to donate traceable (the phones with the new technology to be traced) phones to women's shelters.

Also, the Wireless providers must report to the PSC as to how they spend the grant and how they have made a good faith effort to donate these traceable phones.

I realize that this is incredibly vague and awkward. Please call me in the morning and I will try to explain better our intent. Thanks so much for your help with everything.

- 5 (dm) and to describe the donations." ✓
- 6 3. Page 7, line 11: after that line insert:
- 7 "(dm) *Women's shelter donations.* The commission shall encourage wireless
- 8 providers that receive grants under par. (d) to use a portion of the grants to donate
- 9 wireless telephone handsets with location identification technology to battered
- 10 women's shelters or other organizations that provide a safe haven for victims of
