Amendment to ASA (LRBs0022/1) to AB 61:

Proposal: Provide a portion of the Wireless 911 Fund for Domestic Violence Assistant District Attorney positions.

Page 8, line 11 after "surcharge." create a new (f) 5.:

"5. The commission shall promulgate rules to assess a percentage of the wireless 911 fund to provide Assistant District Attorney positions in Counties with specialized domestic violence prosecutor(s)."

Rationale: 911 calls and domestic violence are connected. Funding the Domestic Violence Assistant District Attorneys through the 911 Wireless Fund, would guarantee continuation of these critical positions while helping to offset the potential reductions of ADA positions (15 in SB 44) within Wisconsin.
