

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 17: delete “(d), or (e)” and substitute “or (d)”.
- 3 **2.** Page 5, line 12: delete “(d), or (e)” and substitute “or (d)”.
- 4 **3.** Page 6, line 13: delete lines 13 to 21 and substitute:
- 5 “**SECTION 13m.** 942.08 (2) (d) of the statutes is created to read:
- 6 942.08 (2) (d) Enters another person’s private property without that person’s
- 7 consent and, for the purpose of sexual arousal or gratification and with the intent to
- 8 intrude upon or interfere with a person’s privacy, looks into any person’s dwelling.”.
- 9 **4.** Page 6, line 15: delete “gratification,” and substitute “gratification and”.
- 10 **5.** Page 6, line 16: delete “and without the consent of each person who is
- 11 present in the dwelling.”.
