

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 6, line 13: delete lines 13 to 21 and substitute:

3 **"SECTION 13m.** 942.08 (2) (d) of the statutes is created to read:

4 942.08 (2) (d) Enters another person's private property without that person's
5 consent and, for the purpose of sexual arousal or gratification, with the intent to
6 intrude upon or interfere with a person's privacy, and without the consent of each
7 person who is present in the dwelling, looks into any person's dwelling.

8 **SECTION 14m.** 942.08 (2) (e) of the statutes is created to read:

9 942.08 (2) (e) Enters another person's private property and, for the purpose of
10 sexual arousal or gratification and with the intent to intrude upon or interfere with
11 a person's privacy, looks into the dwelling of any person in which no person is
12 present.".
