1 At the locations indicated, amend the bill as follows:

1. Page 6, line 13: delete lines 13 to 21 and substitute:

"Section 13m. 942.08 (2) (d) of the statutes is created to read:

942.08 (2) (d) Enters another person's private property without that person's consent and, for the purpose of sexual arousal or gratification, with the intent to intrude upon or interfere with a person's privacy, and without the consent of each person who is present in the dwelling, looks into any person's dwelling.

SECTION 14m. 942.08 (2) (e) of the statutes is created to read:

942.08 (2) (e) Enters another person's private property and, for the purpose of sexual arousal or gratification and with the intent to intrude upon or interfere with a person's privacy, looks into the dwelling of any person in which no person is present.".
