

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 2, line 3: after "member." insert "This paragraph does not apply if the  
3 individual with whom the actor has sexual contact or sexual intercourse is subject  
4 to prosecution for the sexual contact or sexual intercourse under ~~§ 1940.225~~ this section."

5 2. Page 2, line 10: after "individual." insert "This paragraph does not apply if  
6 the individual with whom the actor has sexual contact or sexual intercourse is  
7 subject to prosecution for the sexual contact or sexual intercourse under ~~§ 1940.225~~ this section."
