**SECTION 2. Nonstatutory provisions.**

(1) For the purpose of implementing this act as provided in SECTION 3 of this act, the school board of a nonresident school district may create a waiting list for pupils whose applications to attend school in the nonresident school district in the 2003-04 school year were rejected on or before April 11, 2003, because of lack of space, as provided in section 118.51 (5) (a) 1. of the statutes.
