
Upon review, our association feels the intent of the bill and its implementation would be enhanced by making the following revision in the language of the bill:

- Line one and two on page two should be changed to the following..."specified in s. 45.358 (3) (a) to (g) at the cemetery as long as the cemetery authority is paid in its usual and customary manner for the burial."

This change is important to the WI/Badger State Cemetery Association, to assure that the needs are adequately met for veterans, their families, and cemetery authorities providing services to them during a difficult time.
