

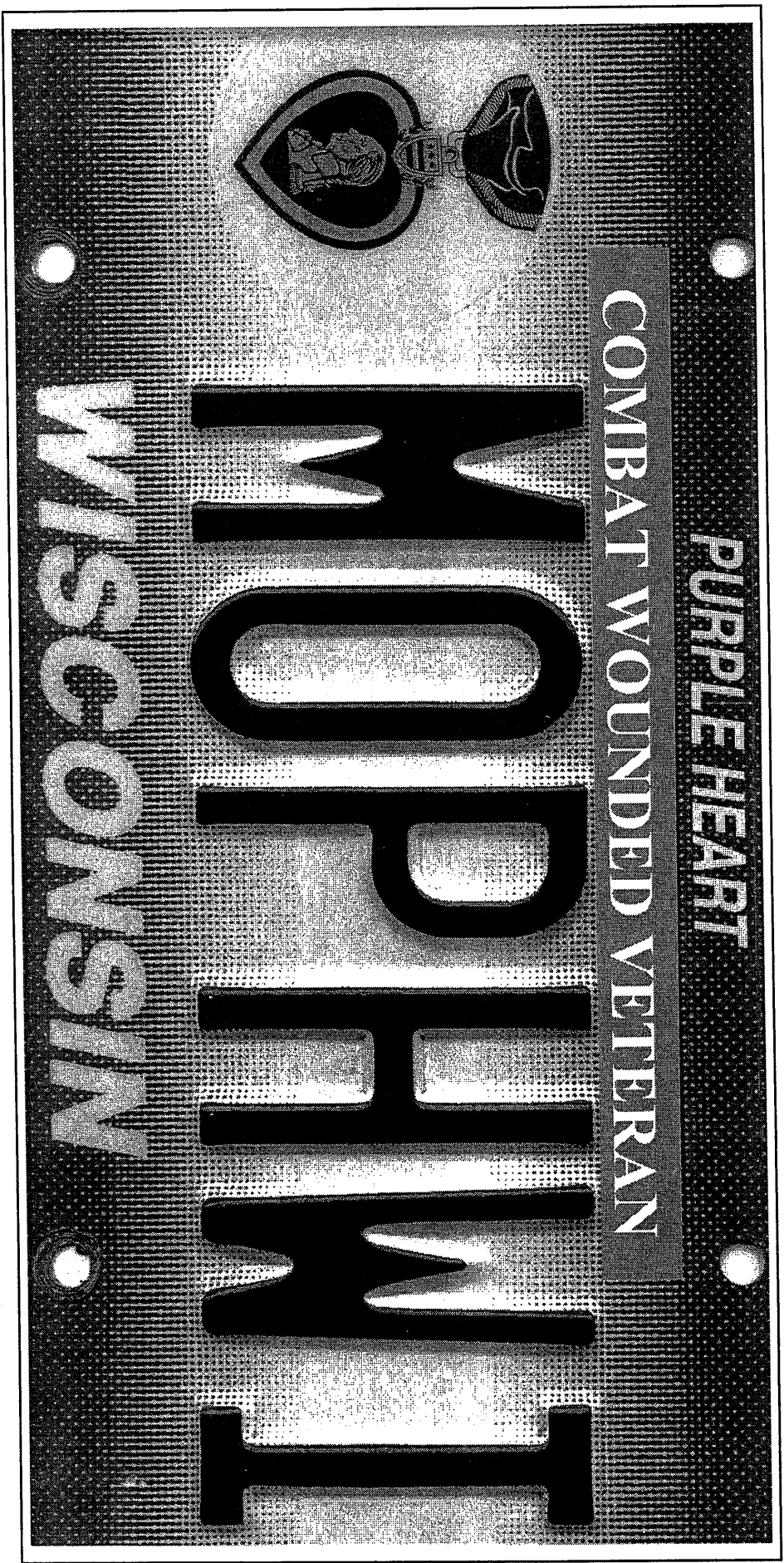

*Analysis by the Legislative Reference Bureau*

\* Under current law, recipients of the purple heart medal military honor may obtain a special distinguishing license plate for most vehicles registered with the Department of Transportation (DOT). A fee, in addition to the regular registration fee for the person's vehicle, is assessed for the issuance or reissuance of the special distinguishing plate.

Under the bill, DOT provides a registration plate decal that displays the words "combat wounded veteran" to each person who has received or who applies to receive a special distinguishing plate relating to being a recipient of the Purple Heart Medal. There is no charge for the decal.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

- 3 SECTION 1. 341.143 of the statutes is created to read:

Under current law, recipients of the Purple Heart Medal military honor may obtain a special distinguishing license plate for most vehicles registered with the Department of Transportation (DOT). A fee, in addition to the regular registration fee for the person's vehicle, is assessed for the issuance or reissuance of the special distinguishing plate.

Under the bill, DOT provides a registration plate decal that displays the words "combat wounded veteran" to each person who has received or who applies to receive a special distinguishing plate relating to being a recipient of the Purple Heart Medal. There is no charge for the decal.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*
