THE MICHIGAN PENAL CODE (EXCERPT)

Act 328 of 1931

750.7 Felony; definition.

Sec. 7.

Felony—The term "felony" when used in this act, shall be construed to mean an offense for which the offender, on conviction may be punished by death, or by imprisonment in state prison.
