***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

5 SECTION 1. 21.49 (3) (a) of the statutes, as affected by 2003 Wisconsin Act 33,  
6 is amended to read:

7 21.49 (3) (a) Any eligible guard member upon satisfactory completion of a  
8 full-time or part-time course in a qualifying school is eligible for a tuition grant  
9 equal to 100% of the actual tuition charged by the school or 100% of the arithmetic  
10 average of ~~maximum~~ resident undergraduate tuitions tuition charged by the 4-year  
11 institutions in the University of Wisconsin System Wisconsin-Madison for a  
12 comparable number of credits, whichever amount is less.

13 SECTION 2. 21.49 (4) (c) of the statutes is created to read:

14 21.49 (4) (c) No guard member may receive a grant under sub. (3) for any  
15 semester in which he or she received a grant under s. 45.25.

16 SECTION 3. 25.36 (1) of the statutes, as affected by 2003 Wisconsin Act 33, is  
17 amended to read:

18 25.36 (1) Except as provided in sub. (2), all moneys appropriated or transferred  
19 by law shall constitute the veterans trust fund which shall be used for the lending  
20 of money to the mortgage loan repayment fund under s. 45.35 (22) and for the  
21 veterans programs under ss. 20.485 (2) (m), (mn), (tm), (u), (v), (vo), (vy), (vz), (w),  
22 (z), and (zm), 45.014, 45.25, 45.35 (23), 45.351 (1), 45.353, 45.356, 45.357, 45.396,  
23 45.397, and 45.43 (7) and administered by the department of veterans affairs,

1 including all moneys received from the federal government for the benefit of veterans  
2 or their dependents; all moneys paid as interest on and repayment of loans under the  
3 post-war rehabilitation fund; soldiers rehabilitation fund, veterans housing funds  
4 as they existed prior to July 1, 1961; all moneys paid as interest on and repayment  
5 of loans under this fund; all moneys paid as expenses for, interest on, and repayment  
6 of veterans trust fund stabilization loans under s. 45.356, 1995 stats.; all moneys  
7 paid as expenses for, interest on, and repayment of veterans personal loans; the net  
8 proceeds from the sale of mortgaged properties related to veterans personal loans;  
9 all mortgages issued with the proceeds of the 1981 veterans home loan revenue bond  
10 issuance purchased with moneys in the veterans trust fund; all moneys received from  
11 the state investment board under s. 45.356 (9) (b); all moneys received from the  
12 veterans mortgage loan repayment fund under s. 45.79 (7) (a) and (c); and all gifts  
13 of money received by the board of veterans affairs for the purposes of this fund.

14 **SECTION 4.** 28.035 (3) (a) of the statutes is amended to read:

15 28.035 (3) (a) The written lease entered into between the Wisconsin state  
16 department of the American Legion and the department of natural resources dated  
17 June 15, 1944, which leases Camp American Legion for a period of 10 years  
18 commencing June 1, 1944, shall continue in full force for an additional 10 years, and  
19 may be renewed for additional 10-year periods thereafter, notwithstanding the  
20 expiration of the term expressed therein, so long as the Wisconsin state department  
21 of the American Legion or any of the American Legion posts organized under s.  
22 188.08 maintains on such property structures which were constructed prior to May  
23 31, 1956, at the expense of the Wisconsin state department of the American Legion  
24 or any such post, for the purpose of the rehabilitation, restoration or recreation of  
25 veterans and their dependents of the Spanish-American war, the Philippine

4 SECTION 5. 45.001 (5) (j) of the statutes is created to read:

5 45.001 (5) (j) Iraq War: Between March 19, 2003, and the ending of Operation  
6 Iraqi Freedom or an operation that is a successor to Operation Iraqi Freedom, as  
7 established by the department by rule.

8 SECTION 6. 45.25 (2) (intro.) and (a) of the statutes, as affected by 2003  
9 Wisconsin Act 33, are amended to read:

10 45.25 (2) ELIGIBILITY. (intro.) ~~An individual~~ A veteran is eligible for the tuition  
11 reimbursement program if he or she meets all of the following criteria:

12 (a) The annual income of the ~~individual~~ veteran and his or her spouse does not  
13 exceed the amount under s. 45.396 (7) (a).

14 SECTION 7. 45.25 (2) (b) of the statutes is repealed.

15 SECTION 8. 45.25 (2) (c) of the statutes, as affected by 2003 Wisconsin Act 33,  
16 is amended to read:

17 45.25 (2) (c) The ~~individual~~ veteran applies for the tuition reimbursement  
18 program for courses begun within 10 years after separation from the service.

19 SECTION 9. 45.25 (2) (d) of the statutes, as affected by 2003 Wisconsin Act 33,  
20 is amended to read:

21 45.25 (2) (d) The ~~individual~~ veteran is a resident at the time of application for  
22 the tuition reimbursement program and was a Wisconsin resident at the time of  
23 entry or reentry into service or was a resident for any consecutive 12-month period  
24 after entry or reentry into service and before the date of his or her application. If a  
25 person applying for a benefit under this section meets the residency requirement of

1 12 consecutive months, the department may not require the person to reestablish  
2 that he or she meets that residency requirement when he or she later applies for any  
3 other benefit under this chapter that requires that residency.

4 **SECTION 10.** 45.25 (2) (e) of the statutes is amended to read:

5 45.25 (2) (e) The ~~individual~~ veteran is enrolled for at least 12 credits during the  
6 semester for which reimbursement is sought.

7 **SECTION 11.** 45.25 (3) (a) of the statutes, as affected by 2003 Wisconsin Act 33,  
8 is amended to read:

9 45.25 (3) (a) Except as provided in par. (am), ~~an individual~~ a veteran who meets  
10 the requirements under sub. (2), upon satisfactory completion of a full-time  
11 undergraduate semester in any institution of higher education, as defined in s.  
12 45.396 (1) (a), in this state, any school that is approved under s. 45.35 (9m), any  
13 proprietary school that is approved under s. 45.54, or any institution from which the  
14 individual veteran receives a waiver of nonresident tuition under s. 39.47, may be  
15 reimbursed an amount not to exceed the total cost of the ~~individual's~~ veteran's tuition  
16 ~~minus any grants or scholarships, including those made under s. 21.49, that the~~ SA 2  
17 individual veteran receives specifically for the payment of the tuition, or the  
18 standard cost of tuition for a state resident for an equivalent undergraduate  
19 semester at the University of Wisconsin–Madison, whichever is less.  
20 Reimbursement is available only for tuition that is part of a curriculum that is  
21 relevant to a degree in a particular course of study at the institution.

22 **SECTION 12.** 45.25 (3) (d) of the statutes is created to read:

23 45.25 (3) (d) Reimbursement of tuition and fees for a course may be provided  
24 at an institution or school under par. (a) other than the one from which the veteran  
25 is receiving his or her degree if all of the following apply:

1           1. The curriculum at the institution or school consists only of courses necessary  
2 to complete a degree in a particular course of study.

3           2. The course is accepted as transfer credits at the institution or school listed  
4 under par. (a) from which the veteran is receiving his or her degree but is not  
5 available at that institution or school.

6           **SECTION 13.** 45.25 (4) (a) of the statutes is amended to read:

7           45.25 (4) (a) ~~An individual~~ A veteran is not eligible for reimbursement under  
8 sub. (2) for more than 120 credits or 8 full semesters of full-time study at any  
9 institution of higher education, as defined in s. 45.396 (1) (a), in this state, 60 credits  
10 or 4 full semesters of full-time study at any institution of higher education, as  
11 defined in s. 45.396 (1) (a), in this state that offers a degree upon completion of 60  
12 credits, or an equivalent amount of credits at a school that is approved under s. 45.35  
13 (9m), at a proprietary school that is approved under s. 45.54, or at an institution  
14 where he or she is receiving a waiver of nonresident tuition under s. 39.47.

15           **SECTION 14.** 45.25 (4) (b) of the statutes is amended to read:

16           45.25 (4) (b) The department may provide reimbursement under sub. (2) to ~~an~~  
17 ~~individual~~ a veteran who is delinquent in child support or maintenance payments or  
18 who owes past support, medical expenses or birth expenses, as established by  
19 appearance of the ~~individual's~~ veteran's name on the statewide support lien docket  
20 under s. 49.854 (2) (b), only if the ~~individual~~ veteran provides the department with  
21 one of the following:

22           1. A repayment agreement that the ~~individual~~ veteran has entered into, that  
23 has been accepted by the county child support agency under s. 59.53 (5) and that has  
24 been kept current for the 6-month period immediately preceding the date of the  
25 application.

1           2. A statement that the individual veteran is not delinquent in child support  
2 or maintenance payments and does not owe past support, medical expenses or birth  
3 expenses, signed by the department of workforce development or its designee within  
4 7 working days before the date of the application.

5           **SECTION 15.** 45.25 (4) (c) of the statutes is amended to read:

6           45.25 (4) (c) ~~An individual~~ A veteran may not receive reimbursement under  
7 sub. (2) for any semester in which he or she received a grant under s. 21.49 or 45.396.

8           **SECTION 16.** 45.35 (20) of the statutes is created to read:

9           45.35 (20) DEPARTMENT HEADQUARTERS AND MUSEUM. The department may  
10 acquire by gift, purchase, or condemnation property for the purposes of providing a  
11 headquarters and museum building for the department.

12           **SECTION 17.** 45.35 (22) of the statutes is created to read:

13           45.35 (22) FUND TRANSFER. The department may loan money from the veterans  
14 trust fund to the veterans mortgage loan repayment fund to fund loans under s.  
15 45.79.

16           **SECTION 18.** 45.35 (23) of the statutes is created to read:

17           45.35 (23) LOAN GUARANTEE. The department may provide a loan guarantee for  
18 multifamily transitional housing for homeless veterans.

19           **SECTION 19.** 45.351 (1j) of the statutes is amended to read:

20           45.351 (1j) HEALTH CARE AID GRANTS. The department may grant to any veteran  
21 or dependents such temporary health care aid as the department considers advisable  
22 to prevent want or distress. Health care aid to meet medical or hospital bills under  
23 this subsection is limited to a payment of up to \$5,000 per veteran or dependent for  
24 a 12-month period beginning with the first day of care for which the person seeks  
25 reimbursement under this subsection. The department may ~~not give prior~~

1 authorization for the payment of health care aid under this subsection but may issue  
2 a certificate of entitlement stating that a veteran or dependent is eligible for a health  
3 care aid grant under this subsection if the treatment is received within a time period  
4 that the department promulgates by rule. The department may not grant health  
5 care aid to pay for care provided to the veteran or dependent before the time period  
6 identified in the certificate of entitlement, except for emergency care as determined  
7 by the department if the application for the health care aid is submitted within 90  
8 days after the emergency care ends. Health care aid may be used to provide payment  
9 for the treatment of alcoholism or other drug addiction or to provide payment for  
10 health care required because of alcoholism or other drug addiction or alcohol or other  
11 drug abuse. The department may not grant health care aid under this subsection  
12 unless the aid recipient's health care provider agrees to accept, as full payment for  
13 the medical treatment for which the aid is to be granted, the amount of the grant, the  
14 amount of the recipient's health insurance or other 3rd-party payments, if any, and  
15 the amount that the department determines the aid recipient is capable of paying.  
16 The department may not grant health care aid under this subsection if the combined  
17 liquid assets of the applicant for aid, and of the veteran and veteran's dependents  
18 who are living in the same household with the applicant, are in excess of \$1,000.

19 **SECTION 20.** 45.356 (2) of the statutes is amended to read:

20 45.356 (2) The department may lend a veteran, a veteran's unremarried  
21 surviving spouse, or a deceased veteran's child not more than \$15,000 \$25,000, or a  
22 lesser amount established by the department by rule, for the purchase of a mobile  
23 home, business, or business property, the education of the veteran or the veteran's  
24 spouse or children, the payment of medical or funeral expenses, the payment under  
25 sub. (6) (e), or the consolidation of debt under sub. (10). The department may

1 prescribe loan conditions, but the term of the loan may not exceed 10 years. The  
2 department shall ensure that the proceeds of any loan made under this section shall  
3 first be applied to pay any delinquent child support or maintenance payments and  
4 then to pay any past support, medical expenses, or birth expenses.

5 **SECTION 21.** 45.356 (3) of the statutes is amended to read:

6 45.356 (3) The department may lend not more than ~~\$15,000~~ \$25,000, or a lesser  
7 amount established by the department ~~by rule~~ under sub. (10), to a veteran's  
8 remarried surviving spouse or to the parent of a deceased veteran's child for the  
9 education of a child.

10 **SECTION 22.** 45.356 (8) of the statutes is amended to read:

11 45.356 (8) No person may receive a loan under this section in an amount that,  
12 when added to the balance outstanding on the person's existing loans under s. 45.351  
13 (2), 1995 stats., and s. 45.356, 1995 stats., would result in a total indebtedness to the  
14 department of more than ~~\$15,000, or a lesser amount as established by the~~  
15 ~~department by rule~~ \$25,000.

16 **SECTION 23.** 45.356 (10) of the statutes is created to read:

17 45.356 (10) Subject to the limit established in subs. (2) and (3), the department  
18 may periodically adjust the maximum loan amount based upon financial market  
19 conditions, funds available, needs of the veterans trust funds, or other factors that  
20 the department considers relevant.

21 **SECTION 24.** 45.356 (11) of the statutes is created to read:

22 45.356 (11) The department may periodically adjust the interest rates for loans  
23 made under this section, which may vary based upon the term of the loan, the type  
24 of security offered, the method of payment, or other factors that the department  
25 considers relevant.

1           **SECTION 25.** 45.356 (12) of the statutes is created to read:

2           45.356 (12) Each loan made under this section, except a loan of \$5,000 or less  
3 made to an applicant whose total indebtedness for loans made under this section is  
4 \$5,000 or less, shall be evidenced by a promissory note and secured by a mortgage  
5 on real estate located in this state. A loan of \$5,000 or less made to an applicant  
6 whose total indebtedness for loans made under this section is \$5,000 or less shall be  
7 evidenced by a promissory note and secured by a guarantor or by a mortgage on real  
8 estate located in this state. A mortgage securing a loan made under this section is  
9 acceptable if the applicant has equity in the property subject to the mortgage equal  
10 to or exceeding a minimum amount that the department establishes by rule.

11           **SECTION 26.** 45.358 (1) (b) of the statutes is amended to read:

12           45.358 (1) (b) “Veteran” means a person who has served on active duty, except  
13 service on active duty for training purposes, in the U.S. armed forces.

14           **SECTION 27.** 45.396 (5) (a) of the statutes, as affected by 2003 Wisconsin Act 33,  
15 is amended to read:

16           45.396 (5) (a) Except as provided in par. (b), the amount of the reimbursement  
17 may not exceed the total cost of the ~~individual's~~ veteran's tuition or the standard cost  
18 for a state resident for tuition for an equivalent undergraduate course at the  
19 University of Wisconsin–Madison per course, whichever is less, minus any grants or  
20 scholarships that the veteran receives specifically for the payment of tuition and may  
21 not be provided to ~~an individual~~ a veteran more than 4 times during any consecutive  
22 12-month period.
