The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1 **SECTION 1.** 45.001 (5) (j) of the statutes is created to read:

2 45.001 (5) (j) Iraq War: Between March 19, 2003, and the ending of Operation
3 Iraqi Freedom or an operation that is a successor to Operation Iraqi Freedom, as
4 established by the department by rule.

5 11 ✓ ^{8/5m} **SECTION 2.** 45.34 (2) (g) of the statutes is created to read:

6 45.34 (2) (g) The person served for 90 days or more in support of Operation Iraqi
7 Freedom or an operation that is a successor to Operation Iraqi Freedom or served in
8 the Operation Iraqi Freedom theater of operation under all of the following
9 conditions:

10 1. Under an active duty order, a unit assignment order, or an involuntary
11 extension of an active duty order.

12 2. Under honorable conditions.

13 3. Between March 19, 2003, and the ending date of Operation Iraqi Freedom
14 or an operation that is a successor to Operation Iraqi Freedom, as established by the
15 department by rule. ✓/0

16 **SECTION 3.** 71.03 (7) (d) of the statutes is created to read:

17 71.03 (7) (d) For taxable years beginning after December 31, 2002, and before
18 January 1, 2005, for persons who served in support of Operation Iraqi Freedom or
19 an operation that is a successor to Operation Iraqi Freedom in the United States, or
20 for persons who qualify for a federal extension of time to file under 26 USC 7508, who
21 served outside the United States because of their participation in Operation Iraqi
