Senator Harsdorf would like to have an amendment drafted to SB 121 (Irb 1955) that does the following:

Rather than the study committee being forced to meet once a month for 15 months, the committee would meet once a month for 15 months, or until the report is completed. If the report is done after 10 months, there's no need for them to meet for 5 months after that.
