1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 41, line 23: delete that line and substitute:

3 "SECTION 135m. 30.206 (2) of the statutes is amended to read:

4 30.206 (2) ~~A general permit~~ In addition to any conditions imposed under sub.

5 (1) (c), a general permit may include any other conditions determined by the
6 department to be reasonably necessary to prevent environmental pollution and to
7 protect the public interest and public rights in navigable waters and the rights of
8 other riparian owners."
