Currently, to perfect certain types of security interests under the Uniform Commercial Code (UCC), a secured party must file a financing statement with the appropriate filing office. These financing statements are made available to the public, generally for the purpose of facilitating commercial transactions. addition, the department of financial institutions (DFI), in cooperation with the registers of deeds in this state, maintains a statewide lien system which, among other things, allows public access to these financing statements with Internet.

Current law specifies certain information that must be included in these financing statements, including a description of the collateral covered by the financing statement or an indication that the financing statement covers all assets or all personal property of the debtor. through

This bill prohibits DFI from disclosing to the Internet any description of collateral in a financing statement that contains personal information. The bill defines "personal information" to mean an individual's social security number, motor vehicle operator's license number, financial account number, or financial account balance or an organization's employer identification number. For purposes of making information contained in such a financing statement available to the public through the Internet, DFI must replace the description of collateral with the following statement: "THE INDICATION OF COLLATERAL IN THIS FINANCING STATEMENT CONTAINS PERSONAL INFORMATION THAT MAY NOT BE

VIEWED OVER THE INTERNET. YOU MAY OBTAIN A COMPLETE COPY OF THE FINANCING STATEMENT FROM THE APPLICABLE FILING OFFICE UNDER S. 409.501, STATS."

Current law generally provides for the use of a standard, national form these financing statements. This standard form contains a box where an individual debtor's social security number or organizational debtor's employer identification number may be recorded. However, because a social security number is not required under Wisconsin law, the standard form generally in use in this state also includes a notice that an individual's social security number is not required in Wisconsin.

This bill amends the standard form generally in use in this state so as to eliminate the box where a social security number or employer identification number may be recorded. In addition, the bill prohibits DFI from disclosing the Internet any social security number or employer identification number listed in a financing statement. For purposes of making information contained in such a financing statement available to the public through the Internet, DFI must replace the social security number or employer identification number with the statement "SSN ON FILE" or "EIN ON FILE," whichever is appropriate.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 409,102 (1) of the statutes is created to read:

409.102 (1) (pp) "Personal information" means an individual's social security number, motor vehicle operator's license number, financial account number, or financial account balance or an organization's employer identification number.

SECTION 2. 409.520 (1) of the statutes is amended to read:

409.520 (1) Mandatory refusal to accept record. A filing office shall refuse to accept a record for filing for a reason set forth in s. 409.516 (2) and may refuse to accept a record for filing only for a reason set forth in s. 409.516 (2). The presence or absence of a social security number on a form of record providing for the insertion of a social security number as such shall not affect the decision of the filing office to accept or refuse the record for filing.

Only for purposes of making information contained in such a financing statement available to the public through the Internet, the department shall replace the social security number or employer identification number with the statement "SSN ON FILE" or "EIN ON FILE," respectively.



Attached is the draft you requested concerning UCC financing statements. As you review the draft, please note the following issues:

- 1. Please review the definition of "personal information" in proposed s. 409.102 (1) (proposed to ensure that it covers all of the types of information you are concerned might appear in a description of collateral.
- 2. Please note that Wisconsin law currently does not require a financing statement to include a social security number, even though the standard form described in the statutes contains a space for the number.
- 3. Under current law, DFI makes available the national, standard form (and instructions) for UCC financing statements. Because this is a standard form, it is likely that Wisconsin residents use this form for filings both within and outside of Wisconsin. This draft requires DFI to alter the form it makes available, so that it is not standard. The altered form may be rejected when presented by Wisconsin residents for filing outside of Wisconsin, thus hindering interstate commercial transactions.

It may be consistent with your intent, and potentially less detrimental to interstate commercial transactions, to leave the form as is and simply rely on the provisions of the bill that prohibit DFI from posting any social security number or employer identification number on the Internet.

3. You may want to have DFI review the draft to ensure that it is administratively feasible. With that in mind, I included a delayed effective date to provide DFI with some lead time to make the necessary adjustments to the statewide lien system.
