1 AN ACT ...; relating to: creating a sales tax and use tax exemption for the sale
2 of game birds.

Analysis by the Legislative Reference Bureau

This bill creates a sales tax and use tax exemption for the sale of game birds to game farms and game clubs.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

This bill will be referred to the Joint Survey Committee on Tax Exemptions for a detailed analysis, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 77.54 (47) of the statutes is created to read:

4 77.54 (47) The gross receipts from the sale of and the storage, use, or other
5 consumption of game birds that are sold to game farms and game clubs.

6 SECTION 2. **Effective date.**

7 (1) This act takes effect on the first day of the 2nd month beginning after
8 publication.
