Amendment 1

- Add the Dept. of Health and Family Services as a member of the Small Business Regulatory Board
- Add one more representative of a small business to the Board, to make it a total of 6 representatives of a small business.

Amendment 2

- Page 5, Line 24 and Page 6, Line 3--strike the word "emergency"
- Page 8, Line 21--add "or fewer"
- Page 8, Section 16--add changes to small business thresholds (25 or fewer employees and \$5 M, versus \$2.5 M)

We are hoping to take Executive Action on these items Tuesday or Wednesday.

TO 2003 SENATE BILL 100

1 At the locations indicated, amend the bill as follows:

2 ✓ 1. Page 5, line 24: delete "EMERGENCY".

3 ✓ 2. Page 6, line 3: delete "emergency".

4 ✓ 3. Page 8, line 20: delete "fewer".

5 ✓ 4. Page 8, line 21: delete "than 25" and substitute "25 or fewer".

6 ✓ 5. Page 8, line 22: after that line insert:

7 "SECTION 15t. 814.245 (2) (b) of the statutes is amended to read:

8 814.245 (2) (b) "Small business" means a business entity, including its
9 affiliates, which is independently owned and operated, and which employs
10 ~~than 25~~ ^{strike} ~~fewer~~ full-time employees or which has gross annual sales of less than
11 \$2,500,000 \$5,000,000."
