 - 11 amend the rule or guideline to remove the unnecessary burden.".
 - 12 **7.** Page 7, line 24: after "rule" insert "or guideline".

- 3 **10.** Page 8, line 4: after “rule” insert “or guideline”.
- 4 **11.** Page 8, line 5: after “rule” insert “or guideline”.
- 5 **12.** Page 8, line 7: after “rule” insert “or guideline”.
- 6 **13.** Page 8, line 9: delete “by the rule since the rule was promulgated” and
7 substitute “by the rule or guideline since the rule or guideline was promulgated or
8 established”.
- 9 **14.** Page 8, line 13: delete that line and substitute “review of its rules and
10 guidelines and any actions taken regarding those rules or guidelines during the
11 previous”.
- 12 **15.** Page 9, line 22: delete “in imminent and substantial”.
