Analysis by the Legislative Reference Bureau

Current law requires the Board of Regents of the University of Wisconsin System (system) to ensure that each system institution incorporates into its orientation program for new students oral and written information on sexual assault and sexual harassment and to supply annually all students enrolled in the system with printed material that includes this information. This bill allows the system to supply the required written or printed information in electronic format.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 36.11 (22) (a) 1. (intro.) and 2. of the statutes are amended to read: 36.11 (22) (a) 1. (intro.) Incorporate in its orientation program for newly entering students oral and written or electronic information on sexual assault and
