- 2 **1.** Page 1, line 3: before "granting" insert "providing an exemption from
- 3 emergency rule procedures,".
- 4 **2.** Page 3, line 2: after that line insert:
- 5 **"SECTION 1m.** 440.05 (intro.) of the statutes is amended to read:
- 6 **440.05 Standard fees.** (intro.) The following standard fees apply to all initial
- 7 credentials, except as provided in ss. 440.42, 440.43, 440.44, 440.51, 440.9935,
- 8 444.03, 444.05, 444.11, 447.04 (2) (c) 2., 449.17, 449.18 and 459.46."
- 9 **3.** Page 3, line 4: delete "\$53" and substitute "the amount specified in rules
- 10 promulgated under s. 440.9935".
- 11 **4.** Page 8, line 22: after "440.9915 (2)" insert ", if the individual has paid the
- 12 fees specified in s. 440.9935".

1 **5.** Page 11, line 4: delete the material beginning with “An application” and
 2 ending with “440.05 (1).” on line 5 and substitute “An application for registration
 3 must be accompanied by a processing fee in an amount established in rules
 4 promulgated by the department. If the department determines to issue a certificate
 5 of registration to an applicant, the department shall require the applicant to pay a
 6 fee for issuing the certificate in an amount established in rules promulgated by the
 7 department.”.

8 **6.** Page 11, line 8: delete “the fee specified in s. 440.08 (2) (a).” and substitute
 9 “a fee in an amount established in rules promulgated by the department, except that
 10 for the first renewal after a certificate of registration is issued, the department shall
 11 prorate the fee based on the length of time between between issuance and renewal.
 12 The amounts established in the rules promulgated under this section shall be based
 13 on the department’s administrative and enforcement costs attributable to processing
 14 applications and regulating athlete agents.”.

15 **7.** Page 16, line 15: after that line insert:
 16 “(2m) The department of regulation and licensing may, using the procedure
 17 under section 227.24 of the statutes, promulgate the rules under section 440.9935 of
 18 the statutes, as created by this act, for the period before permanent rules become
 19 effective, but not to exceed the period authorized under section 227.24 (1) (c) and (2)
 20 of the statutes. Notwithstanding section 227.24 (1) (a), (2) (b), and (3) of the statutes,
 21 the department is not required to provide evidence that promulgating rules under
 22 this subsection as emergency rules is necessary for the preservation of the public
