- 2 **1.** Page 1, line 3: before "granting" insert "providing an exemption from emergency rule procedures.".
 - **2.** Page 3, line 2: after that line insert:
- 5 "Section 1m. 440.05 (intro.) of the statutes is amended to read:
 - **440.05 Standard fees.** (intro.) The following standard fees apply to all initial credentials, except as provided in ss. 440.42, 440.43, 440.44, 440.51, 440.9935, 444.03, 444.05, 444.11, 447.04 (2) (c) 2., 449.17, 449.18 and 459.46:".
 - **3.** Page 3, line 4: delete "\$53" and substitute "the amount specified in rules promulgated under s. 440.9935".
- 11 **4.** Page 8, line 22: after "440.9915 (2)" insert ", if the individual has paid the fees specified in s. 440.9935".

- **5.** Page 11, line 4: delete the material beginning with "An application" and ending with "440.05 (1)." on line 5 and substitute "An application for registration must be accompanied by a processing fee in an amount established in rules promulgated by the department. If the department determines to issue a certificate of registration to an applicant, the department shall require the applicant to pay a fee for issuing the certificate in an amount established in rules promulgated by the department."

Notwithstanding section 227.24 (1) (a), (2) (b), and (3) of the statutes, the department is not required to provide evidence that promulgating rules under this subsection as emergency rules is necessary for the preservation of the public
