Notwithstanding any provision in the condominium documents, an association shall not prohibit the outdoor display of the American **flag** by a unit owner on that unit owner's property if the American **flag** is displayed in a manner consistent with the federal **flag** code (P.L. 94-344; 90 Stat. 810; 4 United States Code sections 4 through 10). The association shall adopt reasonable rules and regulations regarding the placement and manner of display of the American **flag**. The association rules may regulate the location and size of flagpoles but shall not prohibit the installation of a flagpole.
