**ASSEMBLY AMENDMENT ,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2003 ASSEMBLY BILL 418**

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 2, line 3: after “serve” insert “, or is serving,”.

3 **2.** Page 2, line 13: delete lines 13 and 14 and substitute:

4 “(2) Subject to sub. (3), on or after January 1, 2003, a state employee who is
5 required to serve, or who is serving, in the U.S. public health service and who is on
6 detail with any of the”.

7 **3.** Page 3, line 10: after that line insert:

8 “(c) No employee who is eligible to receive the pay and benefits under sub. (1)
9 or (2) may receive the pay or benefits for any service in the U.S. armed forces or the
10 U.S. public health service for any such service before January 1, 2003.”.

11 **4.** Page 4, line 21: after “serve” insert “, or is serving,”.
