TO 2003 ASSEMBLY BILL 409**

1 At the locations indicated, amend the substitute amendment as follows:

2 ✓ **1.** Page 1, line 9: delete lines 9 to 11 and substitute:

3 "45.35 (14) (i) To provide county veterans' ✓ service officers with the information  
4 provided to the".

5 ✓ **2.** Page 1, line 12: after that line insert:

6 "SECTION 2m. 45.35 (14m) of the statutes is created to read:

7 45.35 (14m) ADDITIONAL POWERS. The department may provide county  
8 veterans' service officers with information on all necessary military points of contact  
9 and general deployment information for reserve units of the U.S. armed forces."
