AN ACT to repeal 350.02 (2) (b) 6.; to renumber 100.48 (1) (a); to renumber and amend 347.415 (1); to amend 25.29 (1) (d) 1., 100.48 (1) (b), 100.48 (2), 100.48 (3) (a), 100.48 (4) (a), 100.48 (4) (b), 347.415 (4), 347.50 (1), 347.50 (2), 350.02 (2) (a) 6., 350.02 (3m) and 350.12 (3) (a) 2.; and to create 100.48 (1) (ad), 100.48 (1) (ag), 100.48 (1) (c), 100.48 (4) (c), 347.415 (1g), 350.02 (2m), 350.035 and 350.15 (6) of the statutes; relating to: calculating the estimated snowmobile gas tax payment; operation of snowmobiles by law enforcement officers on highways; operation of snowmobiles proceeding in opposite directions or in excess of roadway speed limits; tampering with odometers of snowmobiles and all-terrain vehicles and with hour meters of boats, snowmobiles, and all-terrain vehicles; transfer of snowmobile registration certificates; exempting accidents occurring in certain snowmobile races or derbies from

requirements to render aid and from reporting and investigation requirements; and providing a penalty.

SECTION 8. 100.48 (3) (a) of the statutes is amended to read:

7 100.48 (3) (a) Nothing in this section shall prevent the service, repair or 8 replacement of an hour meter if the number of hours of operation indicated on the 9 hour meter remains the same as before the service, repair or replacement. If an hour 10 meter attached to farm equipment, a snowmobile, an all-terrain vehicle, or a boat 11 is incapable of registering the same number of hours of operation as before its service, 12 repair or replacement, the hour meter shall be adjusted to read zero, and a sticker 13 shall be affixed by the owner of the piece of farm equipment vehicle or device to which 14 the hour meter is attached or an agent, in proximity to the hour meter, specifying the 15 number of hours of operation recorded on the hour meter prior to its service, repair 16 or replacement and the date on which it was serviced, repaired or replaced. No 17 person who services, repairs or replaces an hour meter attached to farm equipment, 18 <u>a snowmobile, an all-terrain vehicle, or a boat</u> that is incapable of registering the 19 same number of hours of operation as before such service, repair or replacement may 20 fail to adjust the hour meter to read zero or fail to affix the sticker required by this 21 paragraph.

100.48 (4) (a) Any person who violates sub. (2) or (3) (b) with respect to an hour
meter attached to farm equipment may be fined not more than \$5,000 or imprisoned
for not more than one year in the county jail, or both, for each violation.

20	instrument designed to be reset to zero to measure and record the actual distance
21	that a motor vehicle, snowmobile, or all-terrain vehicle has traveled on trips.
