Amendment to Senate Bill 323

- 1. Page 4, line 21: after the period insert: "For purposes of this paragraph, an annexation is considered initiated under s. 66.0223 upon posting of a meeting notice by the governing body of a city or village that indicates that the governing body is considering enactment of an ordinance under s. 66.0223."
- 2. Page 5, line 3: delete the material beginning on that line and ending with the period on page 5, line 6, and substitute:
 - "3. If the court determines that an annexation proceeding described under subd.

 1. was initiated after, but not more than 30 days after, the publication of the notice under sub. (1), the annexation may not proceed until the validity of the incorporation has been determined.".

SENATE AMENDMENT,

TO 2003 SENATE BILL 323



At the locations indicated, amend the bill as follows:

- 1. Page 4, line 21: after the "66.0223." insert "A court shall consider an annexation proceeding under s. 66.0223 to have been initiated upon the posting of a meeting notice by a city or village that states that the city or village is considering enacting an ordinance under s. 66.0223.".
- 2. Page 5, line 4: delete "on or within 30 days after" and substitute "after, and within 30 days after,".
 - 3. Page 5, line 8: after that line insert:
- "4. If the court determines that an annexation proceeding described under subd. 1. was initiated on the same date as the publication of the notice under sub. (1), the court shall determine which procedure was begun first on that date and that action may proceed and the other action may not proceed unless the first action fails."

1 **4.** Page 5, line 9: delete "4." and substitute "5.".
