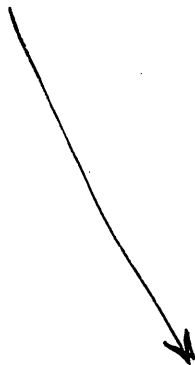

10 to administer a cancer drug".
- 11 5. Page 3, line 15: delete "before the drug is" and substitute "or supplies needed  
12 to administer a cancer drug before the drug or supplies are".
