- 1. **Stays the same**: Page 3, Line 21: delete "par. (b)" and substitute "pars (b) and (c)".
- 2. and 3. Modify the amendment so that Page 4 Lines 5-7 of the bill reads as follows:
- (c) The donation of a cancer drug under sec. 255.055 by the manufacturer of the cancer drug may not increase any liability of the drug manufacturer of a cancer drug that would have existed but for the donation.
