TO 2003 ASSEMBLY BILL 613**

March 4, 2004 - Offered by Representatives STONE and STASKUNAS.

1 **AN ACT to amend** 71.935 (1) (a) of the statutes; **relating to:** setoffs against tax
2 refunds.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** 71.935 (1) (a) of the statutes is amended to read:

4 71.935 (1) (a) "Debt" means a parking citation of at least \$20 that is unpaid and
5 for which there has been no court appearance by the date specified in the citation or,
6 if no date is specified, that is unpaid for at least 28 days ~~and~~; an unpaid fine, fee,
7 restitution or forfeiture of at least \$20; and any other debt that is at least \$20, except
8 debt related to property taxes, if the debt has been reduced to a judgment or the
9 municipality or county to which the debt is owed has provided the debtor reasonable
10 notice and an opportunity to be heard with regards to the debt.
