1 **AN ACT to amend** 814.705 (1) (intro.) of the statutes; **relating to:** sheriff's fees
2 established by the county.

Analysis by the Legislative Reference Bureau

Current law establishes sheriff's fees for various costs incurred by the sheriff in carrying out court-related services, but allows a county board to establish a higher sheriff's fee for service of process, execution of judgment, and travel related to civil and criminal process.

This bill allows a county board to establish a higher sheriff's fee for seizure of property and evictions.

For further information see the *local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
