I and several members of our stuff have reviewed the draft of the proposed changes that you faxed to me vesterday.

Our only real problem with the statutes as they are today was \$14.70(8) where it limits us to "\$10.00 per hour for each deputy assigned to inventory the property when seizing . . ."

Our consensus is that our concerns would be best addressed if we were able to simply leave 59.32 as it is and amend 814,705(1) to read:

• 814.075 Governing body may establish higher fees. (1) With respect to the sheriff's fees enumerated in s. 814.70 (1), (2), (3)(a) and (b), (4)(a) and (b), and (6):

With regard to 814,705(2):

We are concerned with the proposed language that includes ". . . in an amount not to exceed actual cost incurred."

We feel this would be better left at the current \$150.00 because the proposed "actual cost incurred" language for the sale of real estate would likely create an accounting nightmare if we have to document the time of everyone that has a hand in that process. The current \$150 will likely be adequate for several years to come and it's a much cleaner system with a flat rate for this particular service.
