4. Page 5, line 24: Add the following definition:

(f) "Indian tribe" means a federally recognized Indian tribe located in this state.

5. Page 6, line 11: Add "or an organization designated by a participating Indian tribe to fulfill the function of a local health department."

6. Page 8, line 6: Add "municipality, tribal government, the.."

7. Page 9, line 9: Add "department or participating tribe in ..."

7 2. If an agreement described under subd. 1 specifies that the responding agency  
8 is responsible for any personnel or equipment costs incurred in responding to a  
9 request for assistance and if a state plan as described under s. 166.03 (2) (a) 1. is in  
10 effect and the request for assistance is made under the plan, the governmental unit  
11 that receives the assistance is responsible for the personnel or equipment costs  
12 incurred by the responding agency if the responding agency meets the personnel and  
13 equipment requirements in the plan.

14 3. If no agreement under s. 66.0301 for the payment of such services exists, the  
15 governmental unit that receives the assistance is responsible for the personnel or  
16 equipment costs incurred by the responding agency.”

20 command system.”

21 11. Page 8, line 6: delete “or municipality” and substitute “or municipality
