Hi Tim. I have a letter from the Village of Bayside in Milwaukee County which seems to be pointing us to a bill draft.

Bayside and nearby Fox Point use small carts (Cushman Haulster refuse vehicles) to collect waste at the door in their communities. These are small agile vehicles which the villages use because their streets are often small and narrow. The small carts are used to run refuse from curbside to "mother vehicles" parked on main streets. (These "mother vehicles" are large, conventional refuse trucks.) The small carts are favored because of their small turning radii and other maneuverability capabilities.

In 2001 Cushman decided to discontinue manufacture of the on-road version of the refuse cart, which was three-wheeled. They still apparently manufacture a four-wheeled off-road version. The two versions are very similar but the difference is that the off-road versions conform to the current law requirements for a Low Speed Vehicle and (being developed more recently than the on-road versions) have some refinements such as being four-wheeled, having four-wheel brakes, and having a better rollover-protection system.

The Village of Bayside has explored the market availability of on-road refuse vehicles that meet current on-road requirements and has apparently come up empty. They have considered switching to a curbside refuse pickup system using only larger conventional refuse trucks but would much prefer to retain their small-and-large-vehicle system.

SO, we are now to their request of our office. We'd like to draft a bill to allow on-road operation of the currently available off-road Cushman refuse cart. We would the bill to allow on-road operation of off-road vehicles if those vehicles

- vehicles must meet the standards already in law for Low Speed Vehicles, Type Two Motorcycles or Type Two Automobiles
- are designed and manufactured specifically to carry solid waste
- are limited to two occupants (driver and passenger)
- vehicles must be owned by a municipality or its refuse-collection contractee and may only be operated on-street for purposes of refuse collection
- vehicles cannot be operated on streets with posted speed limits greater than 35 MPH
- operators must of course have current, valid WI operator's permits and must be employees of a municipality or its refuse-collection contractee

If there is any problem with any of these points, please let me know. I'm sure we can get where we want to get somehow. In particular, the clause about only allowing these vehicles on streets with posted limits below 35 MPH - if there's a neater way to get at that, we're happy to take advice.

Again, please let me know if there is a question or a problem with any of these requirements. Thank you!

Analysis by the Legislative Reference Bureau

This bill specifically permits the operation of waste transport vehicles on certain roadways of the state. The bill defines "waste transport vehicle" as a motor vehicle that is designed and constructed to carry one or two persons and to transport residential and commercial solid waste (such as garbage, yard waste, and recyclable materials) or numicipal construction, repair, or landscaping materials. As defined in the bill, as waste transport vehicle must meet the equipment standards under state law for a Type 2 automobile or Type 2 motorcycle or the federal equipment standards for a low-speed vehicle and the rehicle is not required to be certified for our read use by its manufactures. Waste transport vehicles are smaller, lighter, and slower moving than most other vehicles (such as garbage trucks) used for such purposes.

The bill permits waste transport vehicles to be operated on roadways under the jurisdiction of a local highway authority that have a speed limit of 35 miles per hour or less, but only if the waste transport vehicle is being used to collect residential or commercial solid waste and being operated by a person employed by, or under contract with, a local governmental unit. However, a local highway authority may restrict or prohibit the operation of waste transport vehicles on any roadway under its jurisdiction having a speed limit of more than 25 miles per hour.

Waste transport vehicles are prohibited from operating on state trunk highways and connecting highways, even where the applicable speed limit is 35 miles per hour or less. However, the bill allows waste transport vehicles to cross state trunk highways or connecting highways at officially designated crossings and at intersections where traffic is controlled by an official traffic control sign, signal, marking, or other device. The bill specifically prohibits the operation of waste vehicles on any roadway having a speed limit of more than 35 miles per hour. A person who violates any of these provisions relating to the operation of waste transport vehicles may be required to forfeit not less than \$30 nor more than \$300.

The bill also does all of the following:

1. Exempts waste transport vehicles from vehicle registration by the Department of Transportation (DOT). Under current law, road machinery, implements of husbandry (agriculture), and certain vehicles that are operated primarily off a highway or to cross a highway are exempt from registration by DOT.

2. Requires an operator of waste transport vehicle to have a valid operator's license or instruction permit authorizing the operation of "Class D" vehicles (primarily automobiles, but also any other motor vehicles that are not commercial

motor vehicles or Type 1 motorcycles).

- 3. Requires the operators of westernspect vehicles to observe the rules of the road, including this state's implied consent law and statutory provisions relating to drunken driving, and subjects violators of those rules to the same penalties as those that apply to violations committed while operating other "Class D" vehicles, including the assessment of demerit points and the imposition of fines, forfeitures, terms of imprisonment, and revocation or suspension of motor vehicle operating privileges.
- 4. Exempts waste transport vehicles from motor vehicle emission limitations and testing.

Frank - I would note the following:

As written, operation (except for crossing) is prohibited on a state connecting highway. Brown Deer Road/Lake Drive is a connecting highway, and we serve residences along those roads. It looks like it would be prohibited to driving up and down those roads under this legislation. [346.94(19) (b)]

I don't believe that Port Washington Road is a connecting highway, but as this is currently written, use of these vehicles could be prohibited by Milwaukee county, if they so desired for some reason. We serve residences along Port Road, and it is the only access to the northern part of the Village, so operation on that road is vital. [349.247 (1) (a)]

Of lesser importance, the use of the vehicles is strictly limited to refuse collection. We sometimes use ours for transporting landscaping materials and so forth, but I don't think its a showstopper.

I have discussed the options with our Fox Point DPW management staff and with my Bayside counterpart, Director of PW Bob Bina. My response to your e-mail below is that Fox Point prefers Option #3, which is worded to provide for "no authority for DOT or locals to further restrict or prohibit on over-25 MPH roads". The goal of both Fox Point and Bayside is to soon effectuate enactment of a new state law. If you sense any DOT discomfort with Option #3, which would slow this process, then we will accept Option # 1.

I request that you respond back with updated Statute changes, once you've finalized the DRAFT legislation.

Mr. Lynett -- Greetings. Sarah Osterberg forwarded to me your e-mail regarding the waste transport vehicles draft. I'm pleased that it generally meets your needs. There are different ways of addressing your requested change to the draft. We live, for better or worse, in a world of (too many) choices so here are several to consider:

- 1. Allow operation on DOT roads where speed limit 35 MPH or less, without DOT authority to restrict or prohibit re over-25 MPH roads (as the draft allows locals to do by ordinance re local roads).
- 2. Same as #1, except allow DOT, by rule, to restrict or prohibit on over-25 MPH DOT roads. This parallels local authority by ordinance re local roads and would be similar to current law on electric personal assistive mobility devices. See ss. 346.94 (18) and 349.236, stats.
- 3. Allow operation on both local and DOT roads where speed limit 35 MPH or less, with no authority for DOT or locals to further restrict or prohibit on over-25 MPH roads. That is, wherever speed limit is 35 MPH or less, waste transport vehicles may be operated without any limitation (assuming conditions of licensure and use for collection are satisfied).

Also, please note that the draft does not specifically address the operation of such vehicles on sidewalks. Current law, however, allows local authorities to permit vehicles to be driven on sidewalks other than at driveways (which is specifically permitted). See s. 346.94 (1), stats., and, for the applicable definition of "local authorities", s. 340.01 (26), stats. So the option is already there if operation on sidewalks other than at driveways is desired. Alternatively, such operation could be specifically addressed in the draft. For your information, legislation last session on low-speed vehicles was silent on sidewalk operation.

Please let me know how you'd like the redraft to meet your needs. Thanks for your help in this matter. --Tim



This bill makes several changes to LRB-2791/P1. First, the bill changes the name of the vehicle from "off-road refuse vehicle" to "off-road utility vehicle" to reflect the expanded permissible uses of the vehicle. Second, those permissible uses are for landscaping and incidental street maintenance. Third, the bill permits the operation of off-road utility vehicles on all roadways — local and state — having a speed limit of not more than 35 miles per hour, without restriction or prohibition by local ordinance.

Finally, please note that the requirement that the operator of the off-road utility vehicle be "employed by, or under contract with, a local governmental unit" remains unchanged. 
