#### Kristina,

I'll take care of this. Would it accomplish your objective if, rather than deleting specific existing trailers from the statute, I simply replaced on p. 2, line 6 of the bill the phrase "or golf cart trailer" with the new phrase "or other trailer for a vehicle for personal recreational use"? (see same language at p. 2, lines 9-10 of 2003 SB 159.) Otherwise, it is possible the change could slightly narrow the scope of the existing statute. For example, the existing statute would apply to a professional motorcycle rider towing a motorcycle trailer, as part of a 3-vehicle combination, to a race. But would this be considered to be for personal recreational use if the statute is modified as indicated? If you do not want any narrowing of the existing statute, I would recommend leaving the specified trailers in the existing text and adding "or other trailer for a vehicle for personal recreational use", as is done in SB-159. Please let me know how you would like to proceed. Thanks. Aaron


