1. Page 2, line 9: delete that line and substitute:

"1. Projects related to tourism that involve retailers classified in the North American Industry Classification System (NAICS), 1997 edition, or the Standard Industrial Classification (SIC) Manual, 1987 edition, published by the U.S. office of management and budget under the following industry numbers:

- a. 721214 — Recreational and vacation camps (NAICS).
- b. 721211 — Recreational vehicle parks and campgrounds (NAICS).
- c. 711212 — Racetracks (NAICS).
- d. 5451 — Dairy product stores (SIC).
- e. 7992 — Public golf courses (SIC)."
