1. Add cross-reference to the air management statutes, Chapter 285, in 93.90 (2) Department duties. This is consistent with the consensus report of the DATCP Livestock Siting Advisory Committee.
2. Restore the democratic rights of all citizens to due process and access to the courts by removing the special definition of "aggrieved person" in 93.90(5) Review of siting decisions.
