Proposed amendments to s. 169.09(2)

169.09 (2) of the statutes is amended to read:

(2) Requirement; commercial hunting. No person may sell or offer to sell or purchase or offer to purchase the opportunity to hunt any wild animal that is or has been captive except as authorized under ~~a bird hunting preserve license.~~ the following licenses and conditions:

(a) Bird hunting preserve license.

** (b) Dog training license, when such hunting does not involve the release of captive wild animals into the wild and does not include shooting, shooting at, intentional killing or attempting to kill any wild animal.

169.09 (3) of the statutes is created to read:

(3) Inapplicability to certain events; entrance fees. Subsection (2) does not apply to:

(a) Fees paid by a person to enter into an organized competitive field trial event involving sporting dog breeds which is sanctioned, licensed or recognized by a local, state, regional or national dog organization when the event is authorized under a valid bird dog or hound dog trail license.

(b) Membership fees paid to join a dog club.

Current Language:

169.09 Hunting of captive wild animals.

(2) Requirement; commercial hunting. No person may sell or offer to sell or purchase or offer to purchase the opportunity to hunt any wild animal that is or has been captive except as authorized under a bird hunting preserve license.

NR 16.01(11) "Hunt" or "hunting" includes shooting, shooting at, pursuing, taking, capturing or killing or attempting to capture or kill any wild animal.

NR 17.001(6) "Hunt" or "hunting" includes shooting, shooting at, pursuing, taking, capturing or killing or attempting to capture or kill any wild animal.

NR 17.001(4) "Dog club" means an organization that owns or leases land for the purpose of training bird dogs or hound dogs to retrieve, point, flush or track game.

NR 17.001(3) "Dog training" means actively developing a dog's ability to retrieve, point, flush, or track game for the purpose of hunting, dog trial competition or hunt testing.

169.20 Dog training licenses.

(5) Restrictions. (a) No person may sell wild animals under a license issued under this section, but a person holding a bird dog training license who has been contracted to train a dog may charge for the wild birds used in the training.



THE DNR is very much opposed to any change that would remove the word "pursue" from the definition of HUNT or the creation of a definition of hunting in ch. 169 that does not include the word pursue.

Pate 2, line 4 - Insert the words "local, state, regional or national" after the words "recognized by a" and before "dog organization" (supposedly this keeps it consistant with other statutory language)
